

RECERTIFICATION OF SOFTWARE COMPANIES - 2026

ANNOTATION

Most IT companies providing FMD solutions were recertified between 11/2022 – 01/2023 (API version 2.4). The currently supported API version is 3.1, and for reporting purposes, version 3.4. Over the **past three years**, many changes have been implemented in the Czech Medicines Verification System (CZMVS). However, software companies may not have incorporated **these updates** into their applications, even though doing so would be desirable from the perspective of the CZMVS operation. Therefore, in line with other countries within the SolidSoft Reply customer group (most of which have already completed this step), we have decided to carry out a **recertification of software companies connected to the CZMVS**.

Certification will take place using the currently supported versions **API 3.1** (or **API 3.4** for reporting). These API versions will remain valid at least until November 2026. Companies are **not required to test bulk operations** unless specifically requested by their clients. Similarly, the **reporting API** needs to be tested only by companies that provide reporting functionality to their customers within their solutions. Both testing and selfcertification take place in the IQE environment.

Note: Software vendors may again request a set of test data (PRODUCT CODE, BATCH, SN, EXPIRY DATE) from CZMVO. Several thousand active SNs (expiring on 31/12/2026) are still available.

RECERTIFICATION STEPS:

- I. **Verify** – and, necessary, **update access to IQE**.
- II. In **IQE**, **verify** that the option „**IT Supplier Qualification**“ is visible in CZMVS. If the option is not displayed in the main sidebar menu, **please contact IT CZMVO team to have it activated**. (it@czmvo.cz).
- III. Follow the instructions in the document "Test-book Qualification" available on the CZMVO website: <https://www.czmvo.cz/en/system-users/it-software-providers-registration-process/>
- IV. **The result** of the self-certification is **automatically sent to CZMVO** (the complete Test-Book is sent to it for review).
- V. CZMVO may request the software company to provide additional information (in particular, whether it uses or intends to use bulk operations or APIs for reports, and whether it uses or intends to use API communication with the Czech Alert Management System (CZAMS)). This information will be included in the certificate.
- VI. Based on the certification results, CZMVO will extend the „**Access Certificate**“ for CZMVS for **3 years**.

Important: The Certificate is issued by CZMVO to a legal entity (a software company) and is therefore not tied to a specific version of software. However, CZMVO has information about the software used and its version and may request a new recertification of the software solution (for example, in the event of significant communication of application issues).

Note: Solidsoft Reply partners mutually **recognize each other's NMVS access certificates**.
